CPCCLRG3001A Licence to perform rigging – basic level

Course Description

This unit specifies the outcomes required to perform basic rigging work associated with movement of plant and equipment, steel erections, hoists (including mast climbing hoists), placement of pre-cast concrete, safety nets and static lines, perimeter safety screens and shutters; and cantilever crane loading platforms for licensing purposes.

This unit is based upon the National Standard for Licensing Persons Performing High Risk Work.

Pre-requisite Requirements

A person undertaking this unit must hold a current National High Risk Work Licence (HRWL) to perform dogging or a current certification for a specific VET course for HRWL to perform dogging that has been issued by, or on behalf of a WHS Regulator.

Licensing/Regulatory Information

This unit in its current form meets state and territory licensing requirements. Any alteration will result in a unit which is not acceptable to regulators for the purpose of licensing.

Selection Criteria

Reading and writing - a learner will be able to read, comprehend and write a range of texts within a variety of contexts.

Oral communication - a learner will be able to use and respond to spoken language including some unfamiliar material within a variety of contexts.

Numeracy and mathematics - a learner will be able to recognise and use a variety of conventions and symbolism of formal mathematics.

Participants must be 18 years of age or older.
